Changes to, adoption of May 17, and June 21, 2023 minutes: Spence moved, Thompson seconded, passed by acclamation.

Treasurer's Report (Thompson): \$4,174.11 balance, 8 of thirteen members/officers present, quorum confirmed.

**Presentation:** Lawrence Transit Route Redesign Presentation, Adam Weigel, Lawrence Transit and Parking Manager. Weigel has been presenting to groups and associations in anticipation of the opening of Central Station projected for January, 2024. Project Phases:

- 1. Mid-Sept: site work and bus shelter substantial completion
- 2. Mid-November: building substantial completion
- 3. January: Route redesign starts, Central Station fully functional. Transit will not offer Sunday service prior to the route change in January.

Transit is implementing a transit app for on-demand service that will also replace the current "My Bus" app. A route preview mode will be available on the app. They are also implementing automated stop announcements and continuing with bus stop improvements. Transit offers travel training for individuals, groups, and organizations. Currently there are seven routes serving downtown. After Jan. 1, there will be five routes serving downtown. In 2024, Transit will work on site selection for a downtown station in a 12-month, 3-step process.

There are several bike-friendly features in Centra Station, including bike lockers, stair ramps, indoor bike storage, and rubber-coated bike racks. Weigel shared some photos of construction site. Spence asked if interlining could be phased in slowly. Weigel stated that there is some interlining now, and more implemented in January. Ellenbecker asked what the building hours would be. Weigel replied that it will be staffed 8-5 Mon-Fri. and the service provider will provide additional hours 5-8 pm on weekdays and on Saturday afternoons. Joyce thanked Weigel for the presentation. ## **Old Business**

- LAN Membership calls update, Holli: She has called ten non-member NA reps, and has not received any replies.
- Report from 6/29/23 meeting, Land Dev. Code committee: Travis Harrod reported that the steering
  committee is pleased with the consultant and their work so far. The consultant has released the first
  draft of module one which addresses residential and commercial zoning and is conducting community
  meetings. Ellenbecker, Thompson and Webber attended the meeting held earlier today on Module 1.

One suggestion from the steering committee would be to change the code to legitimize existing non-conforming development. Ellenbecker asked about occupancy language that changes the code to allowing 5 unrelated persons per rental. She questions the safety of rentals with high density. She also stated that the consultant did not have a good answer regarding covenants and zoning ordinances. Webber stated the consultant did answer the question and stated that covenants override code. Harrod stated that the city could join a covenant lawsuit. Webber asked what motivation the city would have to join a lawsuit. Harrod replied that his point was they could join. Ellenbecker stated the consultant did not address the inequity of this issue.

August 7th MMTC meeting to discuss Neighborhood Traffic Management Program improvements:
 Webber reported that Brook Creek, East Lawrence, Pinkney, Schwegler, and Sunset Hill have asked to
 participate in the MMTC Study Session. Webber will send formal invitations to all 5 neighborhoods and
 notify Kusmyak that representatives will participate.

## **New Business**

- Nitcher asked if other NAs serve alcohol at NA gatyherings, and if insurance is required. Collison stated that ELIA serves beer with a permit in city parks and that this does not require insurance.
- Brad Harrell contacted LAN about presenting a proposed downtown parking enforcement plan and
  soliciting our input. However, the LAN agenda is full in August, and September would be too late. Joyce
  called a special meeting of LAN on Wednesday, July 26, 7:00 pm, via Zoom. All interested parties are
  invited to attend. Webber will post an invitation and the zoom link to the listserv.
